To this end *The Norwood Farmers Market* is a 'juried' event. All crafts are reviewed and chosen by the NFM Committee. The Committee strives to choose a variety of unique crafts, ensuring that your craft(s) will be showcased at this event. We request that you include *three* color photos which will be returned to you *if* you provide a self-addressed stamped envelope with your application.

The enclosed contract/application includes all the information you need to know about the *Norwood Framers Market* & More. In addition, please note:

1. Participation in previous NFM does not guarantee you a space in future NFM. The NFM is a juried event.
2. We cannot process incomplete contracts/applications (those without photographs or all requested information). Please enclose the entire contract-do not cut in half. We consider this as your signed agreement to abide by all our regulations.
3. A non-refundable space fee, as indicated in the contract, payable to: *The Friends of Norwood Center LTD.* is required to be submitted within 10 days of notification of your acceptance to the NFM.
4. **Only handcrafted items are acceptable. The Norwood Farmers Market reserves the right to review craft displays for compliance with this requirement. No dealers, wholesale, or flea market items are allowed.**
5. **Crafters are responsible to bring and set up their own Tents, table and chairs.**
6. We ask that you return your application by April 1, 2017 Acceptances will be within two days of receiving your application.
